Implant dentistry and endodontics often intersect when clinicians face the decision of saving or extracting a tooth. Emerging regenerative strategies, including pulp revascularization, scaffold technologies, and biologically based therapies are discussed in the context of preserving natural dentition. Diagnostic challenges such as cracked tooth syndrome, vitality testing, and periapical disease classification are examined through clinical case presentations. Gary Glassman, DDS, internationally recognized endodontist, educator, and endodontic editor for Oral Health Journal, integrates current evidence and practical experience to guide clinicians in balancing tooth preservation, implant options, and advanced diagnostics.

# Tongue-Tie and Lip-Tie in Infants: Diagnosis, Implications, and Intervention for Breastfeeding Success

Dr. Robert A. Convissar, DDS, FAGD, a Diplomate of the American Board of Laser Surgery and international expert in infant oral surgery, delivers this insightful presentation on the diagnosis and treatment of tongue-tie and lip-tie in breastfeeding infants. Drawing from current medical literature and decades of experience, Dr. Convissar outlines a diagnostic approach using the PEEL<sup>TM</sup> technique and illustrates the functional consequences of untreated ties. Attendees will learn to distinguish between anterior and posterior ties, identify subtle clinical signs, and understand the systemic implications of restricted oral anatomy, including aerophagia-induced reflux and feeding failure. This lecture equips providers with the tools necessary to properly evaluate, diagnose, and refer or treat these conditions, ultimately improving maternal-infant outcomes and preventing unnecessary interventions.

#### Emergency Endodontics and Trauma Management: Clinical Case Review

This clinically focused lecture explores real-world case presentations involving endodontic emergencies and dental trauma. Using a problem-solution framework, Dr. Gary Glassman, DDS, demonstrates how to approach common urgent scenarios such as pulpitis, apical abscesses, and traumatic injuries including root fractures, luxation, and avulsion. Attendees will gain practical insights into diagnosis, treatment planning, and evidence-based emergency care protocols, with emphasis on when to intervene, when to refer, and how to optimize patient outcomes.

## Lecture 2: Susan Maples, DDS, MSBA presents

#### Reflux and Diabetes Detection in the Dental Office

Two significant culprits in the destruction of tooth and bone are acid airway reflux and Type 2 Diabetes. Veteran practitioner and educator, Susan Maples, DDS, MSBA, explores the oral ramifications of these conditions, proper treatment approaches, root cause analysis, ways to facilitate health change behavior in patients, and developing co-referral relationships with medical professionals to develop treatment strategies. Issues discussed include the silent symptoms of reflux and patterns of tooth loss it engenders, pH balance, the impact of sleep apnea as well as diet, the bi-directional relationship between Diabetes and active Periodontal Disease, Insulin Resistance pathology and its progression to Prediabetes and DM2, and the practitioner's role in preventing or improving lifestyle-related systemic disease.

Issues discussed include scope of practice, the history of the nexus between technology and jurisprudence, standard of care as it relates to cost of care and malpractice, who should run the tests or read the results, informed consent and informed refusal, and HIPAA and EMR issues.

## Lecture 4: John F. Dombrowski, MD, FASA presents

## Managing Pain While Preventing Addiction

Veteran pain management expert and anesthesiologist, John F. Dombrowski, MD, FASA, first defines acute pain and then discusses its characteristics, causes and reasons for sufficient treatment follow by a survey of effective surgical, lifestyle, psychological and pharmaceutical treatment options. Areas reviewed include the pain relief/medications abuse tension, the multi-disciplinary team approach, antidepressants, anticonvulsants, muscle relaxants, opioid analgesics, corticosteroids, NSAIDs, topical analgesics, pain evaluation and differential diagnosis, and specialist referral protocol.
